# 2. **HB2330 CRIMINAL LAW: Extends the validity of enhanced handgun carry permits.** Extends the validity of a handgun permit from 8 years to life. Restricts expiration of an enhanced handgun Bricken R. carry permit unless the permit holder no longer meets the necessary requirements.

Comment: TFA opposes this legislation because it seeks to impose on taxpayers the cost of providing firearms training at private facilities. Using TBI data over the last 2 years, the average annual volume of handgun sales by FFL has been approximately 495,000 in 2020 and 457,000 in 2021. If so, the fiscal impact on taxpayers - that is increased taxes to fund this program - could be approximately \$13,500,000 per year assuming annual sales of handguns maintain at or above 450,000 per year. TFA is noting for 2022 electing scoring the support on this bill and will be monitoring votes.

4. **HB477** White M. CRIMINAL LAW: Off duty law enforcement officers carrying firearms into certain locations. Clarifies that a law enforcement officer is not prohibited from carrying a firearm into certain locations regardless of whether the officer is on or off duty. Clarifies that the exemption to the ban on weapons in parks and other similar places for a law enforcement officer applies regardless of whether the officer is on duty. Requires signage in such places to state, "All law enforcement officers are exempt."

<u>Comment:</u> The TN Supreme Court has held that off duty officers are not special classes of citizens but are simply citizens when not engaged in the official discharge of duties. TFA would prefer to see this bill amended to make clear that those citizens who have the "enhanced permits" are at a minimum given the same scope to carry that other citizens - who happen to be law enforcement officers when "on the job" - have. If the bill is not amended to at least include enhanced permit holders, this legislation would continue to perpetuate a non-existent class of "super citizens" comprised only of off duty law enforcement who capacity to defend their lives and their families to elevated much higher with special exceptions than other citizens who merely have other career choices. TFA will monitor and score this bill negatively for 2022 unless amended to include all enhanced permit holders.

5. **HB1735 CRIMINAL LAW: Lowers age requirement for handgun carry permit.** Allows persons 18 years of age or older to obtain an enhanced or concealed handgun carry permit or lawfully carry Todd C. a handgun in public, provided the person is not prohibited from possessing a firearm in this state or any other state and meets all other statutory requirements. Prohibits persons under age 21 from transporting or storing a firearm or ammunition in a motor vehicle in a parking area located on any school campus unless that person is at least 18 years of age and is an honorably discharged or retired veteran of the United States armed forces, including any guard or reserve component.

3. HB1321 CRIMINAL LAW: Reckless endangerment definition and punishment. Specifies that the offense of reckless endangerment applies to actions committed by multiple people as well as individuals. Establishes that motor vehicles are deadly weapons for the purpose of reckless endangerment. Specifies that reckless endangerment in a group of two or more people, from within a motor vehicle or into a motor vehicle is a class C felony that is punishable by the revocation of the person's driver's license for five years. Allows the court to sentence someone guilty of reckless endangerment with a deadly weapon to anger management classes. Establishes a sentence enhancement for acts of reckless endangerment found to be acts of community terrorism. Defines "community terrorism" as an offense committed against a population by members of a criminal gang that regularly engages in gang-related conduct.
