#### Complaint

As a registered voter of Tennessee, I am filing this sworn complaint pursuant to TCA 2-10-108 regarding the August 2022 Senate race for Senate Seat 27.

I was a qualified voter in Williamson County, Tennessee for this election.

I believe, based on the facts stated below, that the actions undertaken by Jack Johnson and/or the political action committees working on behalf of his campaign during this campaign do not conform to the law or rules of the Registry of Election Finance.

During the election of August 2022, the race for Senate seat 27 was contested, with Gary Humble running against Jack Johnson. During that race, there were multiple mailers sent out by several PACs attacking Gary Humble's character and making false and misleading statements that were intended to deceive the public regarding Mr. Humble's political views. The mailers that were sent out are attached to this complaint as Exhibit 1.

While it should never be condoned, many politicians and PACs engage in character assassination, so that is not the basis of this complaint. There was a significant issue regarding the mailers sent out by these PACs: Tennessee Law does not allow candidate's campaigns to coordinate efforts with PACs on supporting or opposing political candidates and requires that PACs that are affiliated with each other disclose that affiliation.

Specifically, I believe the following Rule 0530-01-03-.06 of the Rules of the Tennessee Registry of Campaign Finance was violated:

#### 0530-01-03-.06 DISCLOSURE OF AFFILIATION OF MULTICANDIDATE POLITICAL CAMPAIGN COMMITTEES (PACS).

(1) When registering as a multicandidate political campaign committee (PAC), a committee must disclose its affiliation with any other PACs and provide the names and addresses of those PACs. Such affiliations must be disclosed in the PAC's appointment of political treasurer statement. A committee must notify the Registry if it later becomes affiliated with any other PACs and provide the names and addresses of those PACs within thirty (30) days of the affiliation occurring.

I believe there is substantial evidence that supports the fact that Jack Johnson's campaign unlawfully coordinated with these PACs that sent out the mailers, and that these PACs did not disclose that they were connected to each other.

According to the mailers, they were paid for by the Tennessee Conservatives; the Tennesseans for Student Success and Team Kid PAC; and the McPAC, which is the personal PAC of Lt. Gov. Randy McNally. All of these PACs have connections to Jack Johnson and his campaign.

With respect to the mailers sent out by Team Kid PAC, Harry Allen is or was a boss of Jack Johnson in addition to being on the board of Tennesseans for Student Success. It is unreasonable to believe that Mr. Allen and Mr. Johnson had no conversations regarding the mailers and that Mr. Johnson had no knowledge regarding the mailers being sent out by a PAC on which his boss sits as a board member.

With respect to the mailers sent out by Lt. Gov. Randy McNally's personal PAC (McPAC), it is unreasonable to believe that Lt. Gov. Randy McNally never spoke to Senator Jack Johnson about using his personal PAC to run attack ads against Mr. Johnson's opponent.

Moreover, Ward Baker was Mr. Johnson's campaign manager during the 2002 election. Mr. Baker was accused of illegal coordination a few years ago, though the

complaint against him was dismissed, because it was determined that insufficient evidence was presented by the complainant regarding the coordination (despite the fact that Mr. Baker's essentially admitted it). There was apparently no independent investigation into the coordination performed by the governing body in that instance, which is, in essence, its job to do.

Because there was insufficient evidence presented in the last situation, I am providing what I believe to be sufficient evidence to support my complaint. Attached to this complaint are Exhibits 2-9. These Exhibits establish that Ward Baker, on behalf of Jack Johnson's campaign, was collaborating with the PACs that were sending out mailers against Gary Humble.

Exhibit 2 establishes that Ward Baker is a Founder and President of Anchor Research and Baker Group Strategies. Baker Group Strategies is located at 2000 Glen Echo Road, Ste 200, Nashville TN. Robert Sechrist is a member of the team of Baker Group Strategies.

Exhibit 3 establishes that Robert Sechrist opened Acquire Digital in Nashville, which is also located at 2000 Glen Echo Road, Ste 200, Nashville, TN.

Exhibit 4 illustrates the connection between Ward Baker and Jack Johnson and also another connection between Robert Sechrist and Jack Johnson (a picture depicting Sechrist's son as an intern with Jack Johnson).

Exhibit 5 establishes that another company, American Mail Group LLC is housed in Ste 200 on Glen Echo Road. Another company, Direct Edge Campaigns LLC is also located at Ste 207 Glen Echo Road, just down the hall.

Exhibit 6 establishes the Tennessee Conservatives PAC worked with American Mail Group LLC in July 2022 to send out a mailer against Gary Humble. It also worked with Acquire Digital LLC in July 2022 to send out a mailer against Gary Humble. Both of these companies are housed in the same suite as Ward Baker's group.

Exhibit 7 establishes that Students First PAC made a contribution to Jack Johnson's PAC and that Students First worked with Acquire Digital LLC and American Mail Group LLC and with Direct Edge Campaigns LLC in July 2022 to put out its mailer against Gary Humble.

Exhibit 8 illustrates that Lt. Gov. Randy McNally's McPAC paid Direct Edge Campaigns in July 2022 for its attack mailers against Gary Humble.

Exhibit 9 establishes that Jack Johnson paid Acquire Digital LLC for "advertising" in March- May 2022. He paid Anchor Research for "polling" in September 2022 and for "professional services" in November 2022.

Lastly, Les Williamson is the treasurer of all of the Ward Baker-connected PACs. (No exhibits are necessary because documents filed with this Registry should clearly indicate that Les Williamson is the listed treasurer for the Tennessee Conservatives PAC).

In a meeting a few months ago of the Tennessee Registry of Election Finance, Tom Lawless called for an investigation into the campaign of Gary Humble, stating that where there is "smoke" "you should dig into it." Interestingly, Jack Johnson is an executive in the banking industry and has been for decades, while Tom Lawless is a banking attorney, having served the financial industry for decades. One does not have to be a genius to connect those dots.

If "transparency" is so important, as Mr. Lawless has claimed in the past, I believe I have presented more than enough evidence of "smoke" to raise a strong suspicion of unlawful campaign coordination on the part of Jack Johnson's campaign. If there is a true interest in election integrity and in ensuring that the public is not deceived, the Registry of Campaign Finance should look into this situation and report its findings back to the public.
